### Board Members' Reports

President - Kumpy Kump

- A Zoom meeting was held with Wendy regarding motorsport registration and insurance policies.
- Refunds for cancellations require proof (e.g., doctor's note, accident report).
- Decision: Continue issuing refunds/credits for non-participation.
- Event Scheduling and Logistics:
  - Discussion on race schedules and potential conflicts.
  - Ridge race track checklist sent and approved.
  - Need to coordinate semi-truck transport for air fences (\$1,500 estimated cost).
  - Payment to Ridge is pending (\$32,000 due).
  - Medical services: Switched from Medic One to Adventure Medics due to cost increases (\$2,080 per day for two ambulances).
    - Ensured an ALS (Advanced Life Support) unit is available for all races.

- Facility & Storage Updates
  - Decision to retain Paddock B at the Ridge for sufficient space (\$2,625 per weekend).
  - Pacific Raceway storage: Reduced from six to four containers (\$1,200 per month storage cost).
  - Garrett Visser will store three trailers for \$200 per month and handle container valuation.
- Insurance Policies & Costs
  - Breakdown of insurance expenses:

D&O Insurance: \$1,220General Liability: \$9,526Umbrella Policy: \$7,243

- Personal Accident Coverage: \$2,200
  - **Total:** ~\$17,000 annually.
- Chris Lafayette requested payment for container relocation and logistics work (\$25/hr, hours TBD).
- Jacob Marshall returning for crash truck support (\$599 for the season).
- Proposed fun events during race weekends:
  - Easter egg coloring contest
  - Connect Four competition.
  - Non-motorized bike lap race (pending insurance approval).
